## TAKLIMAT PENCEGAHAN RASUAH DI NEXUS PREVENTION OF CORRUPTION TALK AT NEXUS

Perbuatan yang boleh dikategorikan sebagai rasuah, hukuman denda dan penjara kepada pesalah, cara mengelakkan rasuah dan pentingnya integriti dalam pekerjaan antara intipati taklimat mengenai pencegahan rasuah yang telah diadakan di ibu pejabat Nexus pada 22 September 2020. The talk, organised to instill awareness among staff and associates on corruption prevention, was delivered by Dayang Hajah Norashiken Haji Mat Salleh, Senior Special Investigator from the Anti-Corruption Bureau. About 90 staff and associates from Nexus, DST DevCo and Evolve.Me attended the talk which ended with a question and answer session.*
